What is BIZSAVE?

The BIZSAVE plan gives you a 22% discount off our standard energy usage rates when you pay your bill on time. Plus an additional 1% pay on time discount (23% total for energy usage) when you pay your bill by Direct Debit.

Which rate applies to me?

Single Rate all times:

This tariff consist of a fixed daily charge, and then a flat per kWh energy rate which is the same at all times of the day or night. As such the tariffs does not have a different price for peak and off peak. Although "Controlled Load" rates might apply. This tariff is the basic network tariff for general usage for most cases.

Controlled/Dedicated load rates:

These tariffs consist of rates for "time-switch" controlled hot water services, immersion heaters, space heaters and other dedicated loads, generally controlled between 11pm and 7am.

Time of Use – 5 Day Peak / Off Peak:

"Time of use – 5 Day Peak / Off Peak" tariffs consists of a fixed daily rate, and different per kWh energy rates for peak times and off peak times. The peak times are generally between 7am and 11pm Monday to Friday, and all other times are off peak.

Time of Use – 7 Day Peak / Off Peak:

"Time of use – 7 Day Peak / Off Peak" tariffs consists of a fixed daily rate, and different per kWh energy rates for peak times and off peak times. The peak times are generally between 7am and 11pm Monday to Sunday, and all other times are off peak.
